APPLICATION IN TERMS THE DEVELOPMENT FACILITATION ACT, 1995:THE PROPOSED APPLICATION ON PORTIONS 1, 2, 3 & 4 OF THE FARM VALENCIA 449 KR AND PORTION 87 OF BUISKOP 464 KR: PROPOSED EXTENSION OF KLEIN KARIBA RESORT.

Kindly be informed that the application for a land development area in terms of the Development Facilitation Act, 1995 on portions 1,2,3 and 4 of Valencia 449 KR and portion 87 of the farm Buiskop 464 KR is supported subject to the following conditions:

- 10.1. That the applicant submit the site development plan and building plans to the Municipality for approval prior to any new/additional development.
- 10.2. That the Municipality will not provide services to the development. However Standard Conditions in the SDF must be complied with. The following further conditions from Technical Services and Community Services Departments in the Municipality must also be complied with:
- (a). Water licenses must be obtained for all boreholes from the Department of Water Affairs(DWA);
- (b). Water quality assessment must be done according to the standards in terms of the service agreement to be signed by the developer and the municipality to ensure that water is potable and suitable for domestic use.
- (c), Waste Water Treatment works license must be obtained from DWA.
- (d). The effluent must be of the acceptable quality in terms of the service

agreement(to be signed by the developer and the municipality), to be used for irrigation of the recreational facilities (lawns and/or golf course).

- (e). All water and waste water assessment results must be submitted to the municipality in terms of the service agreement;
- (f). The issue of waste disposal as depicted in the EIA report complies with legislative requirements and authorized by the relevant authorities (this also implies the applicant's transfer station).
- (g) Only domestic/general waste will be allowed in the municipal landfill site;
- (h) Usage of enclosed transportation of waste is required to avoid scattering of waste:
- (i) The applicant to cooperate with the landfill operator for disposal of waste.
- 10.3. That the Record of Decision by the Department of Economic Development, Environment and Tourism(DEDET) be submitted to the Municipality prior to commencement of the actual construction.
- 10.4. That 3x copies of Map 3 and Annexures indicating approved rights must be submitted to the Municipality for purposes of amending the Land Use Scheme, upon approval by the Development Tribunal.
- 10.5. The applicant shall comply with all requirements/conditions applicable to Resorts as outlined in the SDF.
- 10.6. That all conditions in terms of the Bela-Bela Land Use Scheme be complied with.
- 10.7. The retirement village must be approved as part and parcel of the Resort and not as a separate township development. When considered as a separate development from the resort the village will be inconsistent with the SDF as this would amount to lifestyle estate which prescribes low density of 1 dwelling unit per 5ha.
- 10. 8. This development should be treated as unique, given the new concept/philosophy/approach that the ATKV group is planning to implement in all its resorts throughout the country and not be used as precedence for other developments where there might be deliberate attempt to establish townships outside the urban edge. Each

application will be treated on its own merit.

- 10.9. The applicant shall comply with all other statutory requirements by other statutory bodies and support to this application does not exempt the applicant from complying with such requirements.
- 10.10. The applicant shall submit proof that he has complied with all relevant requirements and conditions before commencement with any of the additional rights that would have been approved by the Development Tribunal.
